



# Declaration for an exemption of GST on a car or car parts – person with a disability who is gainfully employed

## Who should use this declaration?

If you are a person with a disability who is eligible to buy or lease a car, or buy car parts GST-free, you must present this declaration to your motor vehicle or car parts supplier.

! You do not need to send this declaration to the Australian Taxation Office. This declaration needs to be kept by your supplier to support supplying the car or car parts to you GST-free.

You or your authorised person must sign and date the declaration before providing it to your supplier.

We recommend you keep a copy of this declaration and any supporting documents for your records.

– *the Managing Director of the nominated company within the meaning of Part 2 of the Hearing Services and AGHS Reform Act 1997, or*  
– *an officer or employee of that company who is authorised in writing by the Managing Director for the purposes of section 38-510 of the A New Tax System (Goods and Services Tax) Act 1999.*  
*certifying that I have lost the use of one or more limbs (upper or lower) to such an extent that I am unable to use public transport.*

My declaration relates to:

**A car**  
From the date of purchase or lease, I intend to use the car described in Section B in my personal transportation to or from gainful employment for either:  
■ a period of two years, or  
■ until the car has travelled 40,000 kilometres.

I request that this car be supplied to me GST-free under section 38-510 of the *A New Tax System (Goods and Services Tax) Act 1999*.

I understand that if the GST inclusive market value of the car exceeds the car limit, GST is payable on the excess.

**Car parts**  
From the date of purchase, I intend to use the car parts described in Section B in a car used by me in my personal transportation to or from gainful employment.  
I request that these car parts be supplied to me GST-free under section 38-510 of the *A New Tax System (Goods and Services Tax) Act 1999*.
