## **An Act to amend the law in relation to higher education, and for related purposes**

*[Assented to 24 November 2010]*

The Parliament of Australia enacts:

### **1 Short title**

This Act may be cited as the *Higher Education Support Amendment (2010 Budget Measures) Act 2010*.

## 2 Commencement

- (1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

## 3 Schedule(s)
