### Goods and Services Tax Ruling

Goods and services tax: attributing GST payable, input tax credits and adjustments and particular attribution rules made under section 29-25

This Addendum amends Goods and Services Tax Ruling GSTR 2000/29 to reflect the amendments to the A New Tax System (Goods and Services Tax) Regulations 1999 resulting from the commencement of the A New Tax System (Goods and Services Tax) Amendment Regulations 2007 (No. 1). This Legislative Instrument changes the threshold amount for the requirement to issue a tax invoice from 1 July 2007.

#### **GSTR 2000/29 is amended as follows:**

**1. Footnote 9**

Omit '\$50'; substitute '\$75'.

**2. Footnote 26**

Omit '\$50'; substitute '\$75'.
