## Luxury car tax: what is the luxury car tax threshold and the fuel-efficient car limit for 2014-15 financial year?

#### Preamble

### Ruling

1. The luxury car tax (LCT) threshold and the fuel-efficient car limit are determined in accordance with Division 25 of the *A New Tax System (Luxury Car Tax) Act 1999* (LCT Act).

### Luxury car tax threshold

2. The LCT threshold is indexed annually according to a factor to be determined by Parliament or, if such a factor is not determined by Parliament, indexed annually in accordance with movements in the All Groups Consumer Price Index (All Groups CPI).<sup>1</sup>

3. Parliament has not determined an indexation factor, so for the 2014-15 financial year the LCT threshold will be indexed in accordance with movements in the All Groups CPI unless the indexation factor is 1 or less.<sup>2</sup>

4. For the 2012-13 financial year the index was 406.6 and for 2013-14 financial year this index was  $417.0^3$  resulting in an indexation factor of 1.026. For the 2013-14 financial year, the LCT threshold was \$60,316.<sup>4</sup> The LCT threshold for the 2014-15 financial year is \$61,884 (\$60,316 x 1.026).

### Fuel efficient car limit

5. The fuel efficient car limit is indexed annually in line with movements in the motor vehicle purchase sub-group of the CPI,<sup>5</sup> unless the indexation factor is 1 or less.<sup>6</sup>

6. For the 2012-13 financial year this index was 395.1 and for the 2013-14 financial year the index was 384.6<sup>7</sup> resulting in an indexation factor of 0.973. As the indexation factor is less than 1, the fuel-efficient car limit will not be indexed. For the 2013-14 financial year, the fuel-efficient car limit was \$75,375.<sup>8</sup> The fuel-efficient car limit for the 2014-15 financial year remains at \$75,375.

### Date of effect

7. This Determination applies to the financial year commencing 1 July 2014.
