OTHER RULINGS ON TOPIC ST 2010

Clarification has been sought of the kinds of baby DREAMBLE lambskin rugs that qualify for exemption under item 124(5), First Schedule.

RULING Lambskin rugs for use with a bassinette, cradle, cot, 2. perambulator or other infant carrying device mentioned in item 124, First Schedule, may qualify for exemption under item 124(5) where the rugs are advertised and marketed for use with the products mentioned and are of a size consistent with their use by infants.

> Larger rugs may qualify for exemption under item 124(5) in appropriate cases but they would need to be of reasonable dimension and be advertised and promoted as baby rugs with emphasis on bassinette, cradle, cot, perambulator use, etc.
