Addendum

This Addendum amends Taxation Determination TD 98/22 as follows:

Paragraph 6

Delete the formula for calculating the minimum yearly loan repayment and replace it with:

Amount of the loan not repaid by x Current year's the end of the previous year of income benchmark interest rate

$$1 - \left(\frac{1}{1 + Current \ year's \ benchmark \ interest \ rate}\right)^{Remaining \ term}$$

$$= \frac{100,000 \times 0.067}{1 - \left(\frac{1}{1 + 0.067}\right)^{5}}$$
