## **Schedule 1—Amendments**

#### **1 Subsection 206(2A) (heading)**

Repeal the heading, substitute:

*Prohibited psychoactive substances, tobacco products and  
prohibited serious drug alternatives*

#### **2 Paragraph 206(2A)(b)**

After “prohibited psychoactive substance”, insert “, tobacco products”.
