This Determination, to the extent that it is capable of being a 'public ruling' in terms of Part IVAAA of the *Taxation Administration Act 1953*, is a public ruling for the purposes of that Part. Taxation Determination

Fringe benefits tax: what is the benchmark interest rate to be used for the fringe benefits tax (FBT) year commencing 1 April 1996?

- 1. The benchmark interest rate for the FBT year commencing 1 April 1996 is 10.50 per cent per annum. There has been no change to the rate of 10.50 per cent that has applied for the past year.
- 2. The rate of 10.50 per cent is used to calculate the taxable value of:
 - a fringe benefit provided by way of a loan;
 - a car fringe benefit where an employer chooses to value the benefit using the operating cost method.

Example

On 1 April 1996 an employer lends an employee \$60,000 for five years at an interest rate of 6% per annum. Interest is charged and paid 6 monthly and no principal is repaid until the end of the loan. The actual interest payable by the employee for both the past year and the current year is \$3600 (60,000 x 6%). In the current year, with a benchmark interest rate of 10.50% per annum, the taxable value is \$2700 [(60,000 x 10.50%) - \$3600].
